





Professional Services Data Sheet



SpinetiX Data Storage Region Migration Service

This service provides a one-time migration of customer account's data and players, and optionally its users, from one data storage region to another. It includes the reconfiguration of Single Sign-On (SSO) if previously activated. The migration ensures continuity and compliance with customer-specific data residency requirements.

Account Migration Procedure

This migration requires a downtime, during which users will not be able to use the account being migrated; however, players will continue to display their content during the migration although they may reboot twice.

Customers must update their network firewall configuration to allow connections to SpinetiX HUB for the new data storage region before migration. Furthermore, all players should be running DSOS™ version 4.7.0 or later and Elementi software should be updated accordingly if used by the customer.

If SSO has been set up a new SSO integration will need to be set up prior to the migration to be able to migrate the SSO users, if not the SSO users will not be migrated. Users which only have access to the account being migrated will be migrated as well, except for SSO users if the new SSO migration is not available. Users without SSO will receive a new password after migration. Users with access to accounts other than the account being migrated are not migrated. In any case all users which had access to the account before migration retain access to the migrated account, even if they are not migrated.




